Since 2022 he has prioritized changes to staffing, processes, and ordinances as well as updates to the City's Master Land Use Plan and business development efforts.

Prior to Dearborn, Jordan led Ferndale, Michigan's development and planning efforts, and served as executive director of a regional nonprofit serving 13 cities and 3 counties. 


